**ORDER AUTHORIZING
EXAMINATIONS PURSUANT TO RULE 2004 OF THE
FEDERAL RULES OF BANKRUPTCY PROCEDURE**

Upon the motion of petitioners Gordon MacRae and G. James Cleaver, by their attorneys, for an order pursuant to Fed. R. Bankr. P. Rule 2004, to examine certain individuals and an appropriate representative of the entities identified herein, and for sufficient cause appearing therefore, it is

ORDERED that petitioners Gordon MacRae and G. James Cleaver shall be, and hereby are, authorized pursuant to FRBP Rule 2004 to take the examinations of an appropriate representative of Wachovia Corporation, John Johnson, Austin Jones, an appropriate representative of Citibank, Tom Atkinson, Daniel Biela, John Ha, an appropriate representative of IM Partners and Jim Knapp (each an “Examinee” and collectively the “Examinees”). It is further

ORDERED that each Examinee shall appear to be examined at the offices of ZEISLER & ZEISLER, P.C., located at 558 Clinton Avenue, Bridgeport, Connecticut 06605 (or at any other location agreed to in writing by the Petitioners, through their counsel, and such Examinee), on the following dates and at the following times:

A. with respect to Tom Atkinson, Daniel Biela and John Ha, on November 3, 2005 beginning at 9:00 a.m.;

B. with respect to the appropriate representative of IM Partners and Jim Knapp, on November 4, 2005 beginning at 9:00 a.m.;

C. with respect to the appropriate representative of Wachovia Corporation, John Johnson and Austin Jones, on November 7, 2005 beginning at 9:00 a.m.; and

D. with respect to the appropriate representative of Citibank, on November 8, 2005 beginning at 9:00 a.m.;

provided, however, that the foregoing date and time with respect to each particular Examinee may be hereafter modified by a written agreement signed by or on behalf of the petitioners and such Examinee.
